### ROUTES TO THE TRIAL

**FROM THE NORTH:** I-55/70 to IL 159; south on IL 159 to IL 161; turn left (east) on IL 161 to Lebanon Ave (first stoplight); turn left on Lebanon Ave to West Blvd; turn right on West Blvd; turn left on Eastview Drive. If you pass FunSpot skating rink, you have gone to far.

**FROM THE SOUTH:** I-55 to I-255 east/north; I-255 east/north to IL 15 east; east on IL 15 to IL 159; turn left (north) on IL 159 to East B Street (approximately 1.5 miles-second street after the fountain); turn right on East B Street to West Blvd (approximately 2 miles); turn left on West Blvd to Eastview Drive. If you pass Ameren IP, you have gone to far.

**FROM THE EAST:** I-64 to IL 159 south; IL 159 to IL 161; turn left (east) on IL 161 to Lebanon Ave (first stoplight); turn left on Lebanon Ave to West Blvd; turn right on West Blvd; turn left on Eastview Drive. If you pass FunSpot skating rink, you have gone to far.

**FROM THE WEST:** I-64 to IL 159 south; IL 159 to IL 161; turn left (east) on IL 161 to Lebanon Ave (first stoplight); turn left on Lebanon Ave to West Blvd; turn right on West Blvd; turn left on Eastview Drive. If you pass FunSpot skating rink, you have gone to far.

To Carey Animal Hospital: Turn right onto Eastview Dr; turn right onto West Blvd; turn left onto Lebanon Ave; make a right onto IL-161/N Belt E.; End at 312 North Belt East

To Animal Emergency Center: Turn right on Eastview Dr; turn right onto West Blvd; turn right onto Lebanon Ave; in 2.2 mi. turn left onto N Green Mount Rd; in 2.1 mi. merge onto I-64 W via the ramp on the left toward East St Louis; merge onto I-255 N via Exit 7 toward Chicago; in 4.8 mi. merge onto I-55N/I-70 E via Exit 25A toward Chicago/ Indianapolis; in 1.2 mi take the IL-157 exit, Exit 11, towards Collinsville/Edwardsville; turn right onto N Bluff Rd; turn right onto The Mall St, 2005 Mall St is on the left.
